Rationale: The Conduct, Ethics and Discipline Standards Policy of BC Soccer isn't the name of the document/policy anymore. It has been updated to the Judicial Code & Policies of BC Soccer. By amending the bylaw to be more generic, it achieves the same thing and doesn't become outdated when BC Soccer updates its policies.

The President's Address:

To put things mildly, the last year has been extremely challenging for everyone associated with the club from the President, to the board, to the staff, to our coaches and volunteers and for our members. This said, in addition to presenting unprecedented challenges for our club, the COVID 19 pandemic has proven our club's ability to find solutions and deliver excellent soccer experiences to the Comox Valley's children. Further, the pandemic has also enabled our club to find opportunities to improve the way we deliver and manage programming in a more efficient

and effective way. Case in point, due to the need for new processes, our club has begun a complete review of all of our policies and procedures such that they are in line with more modern ways of working. Further, from a technical perspective, COVID has necessitated that we make efficient our training model, meaning that we have universally adopted the CSA's skill centre methodology. The good news behind this is that we are well positioned to apply for a skill centre license.

Financially, I am happy to report that despite the challenges of the pandemic, the club is in a healthy financial position and only suffered a small operating loss over the last fiscal year. Moreover, although we have had to adjust pricing slightly on our programming, we are still the most affordable club on Vancouver Island and will continue to be for the foreseeable future. Although we saw the departure of our previous TD who departed for family reasons, we have been very fortunate to bring in Mr. Craig Angus into our team and his contributions have been outstanding. Craig is a UEFA A and Elite Youth license holder, meaning that he is one of the most qualified coaches in Canada. For a small community to have such a talented and educated individual leading us technically is wonderful. Finally, Craig has ensured that an evidence-based approach is taken for all technical decision making and that a objectively standards based approach will be followed for delivery of programming. Both of these elements are key for the club moving forward.

From a governance perspective, we are entering the AGM with a strong board and many new faces interested in joining. I look forward to working with new and old members alike as we venture into a new era. On this note, while we attained BC Soccer's Charter status this year, we are carrying our work forward and will be looking to attain Canada Soccer's Quality Soccer provider license in the near future. This means that we will continue to improve our standards for program delivery in all aspects.

Final point – I'm extremely pleased to announce that the club will have a new logo going forward. As I am looking to sit as the club president for another term, I view this rebranding as the next evolution for the club as we move forward and continue to modernize.
